1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

Rajeev Gandhi Government Post Graduate College, Ambikapur was established on 06 July 1960 in Kumar Palace Ambikapur with Degree Courses in all the three faculties – Arts, Science and Commerce and Law faculty with UG Programs started in 1973. Having completed twelve years of valuable service to higher education in the predominantly tribal area of then Madhya Pradesh, it was shifted in 1970 to its own government building and was granted the status of Post Graduate College in 1972 with Post Graduate courses in Hindi, English, History, Political Science, Sociology, Economics, Geography, Chemistry, Botany, Zoology, Mathematics, Commerce and Geology. The College aims to cater to the Higher Education needs of students hailing mostly from the marginalized tribal and deprived sections of the society and mould them into better citizens contributing constructively towards the achievement of national goals and cherishing the values of secularism and national harmony. The objective of the institution is to equip learners with the quality education in such a way that they are able to cope with the challenges and demands of the contemporary global society. The guiding principle of the College is to seek for academic excellence by effectively conducting curricular and co-curricular activities, to achieve all round development of personality of the learners and to attain social and communal harmony in accordance with the cherished ideals of the Indian State.

The College strives to exert all its resources to mould and motivate the students hailing mostly from underprivileged sections of society, viz., Scheduled Caste, Scheduled Tribe and Minority to be better individuals and human beings and groom them to contribute constructively towards achieving the national goals by upholding the values of secularism, social commitment and global harmony. We have a very clear vision that the students going out of our campus should be morally strong, dedicated to nation and humanity as a whole and highly efficient at work. We further aim at moulding the learners who are academically accomplished, morally upright, emotionally calm and quiet, rooted in the social ethics, with determination to uphold and champion for the cause of justice, peace, harmony and development.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

Being an autonomous college at the Post Graduate level of courses and programmes , this institution designs the curricula for PG classes which are conducted here. The total number of PG programmes under the autonomous system at present is fifteen . One PG programme (L.L.M) following the affiliating university curricullum.

The curricula designed by our Autonomous Cell have multiple relevance and come under regular periodic revision and updation resulting into their being more and more useful in terms of content richness and relevance.

Employment oriented and skill based courses form the integral part of all the PG programmes, as under the CBCS curriculum framework the students have a compulsory option to choose one paper which focuses on the enhancement of employability of the students through strengthening their various skills.

Teaching-learning and Evaluation

The college abides by all the rules and policies laid down by the UGC and State Government of Chhattisgarh and the parent University regarding admission i.e. reservation policies, admission process, eligibility, criterion, wastage etc. The admission in the college has been processed online, the transparency since last four years.

The college ensures fair admissions through admission committees that all the rules, regulations and provisions laid down by the department of Higher Education, Government of Chhattisgarh are followed. The admission is provided after careful scrutiny of credentials and testimonials by the members of the concerned admission committee after paying the fees by the students seeking admission in the stipulated time. If he fails to pay the fees, the candidates from the waiting list of the same category are entertained.

After the admission is over, the learning capacity of the student is assessed through comprehensive questions, quiz unit tests by the concerned teachers of the department and the slow learners are coached in remedial coaching in extra classes and they are also encouraged to consult the teachers in the departments to enable them to come in the mainstream.

The college has 50 full time teachers against the sanctioned post of 73 (11 professors and 62 assistant professors). Out of them 28 have Ph. D. degree, 11 M. Phil and 12 are NET / SET qualified. All are well qualified, use computer technology for effective teaching with LMS and E- learning resources. They are research oriented, regularly attending seminars, workshops, conferences and symposia, perusing MRP,

presenting and publishing research papers and books. CBCS courses have been adopted under autonomous scheme. Experiment, participative and problem solving methodologies are used for enhancing learning experiences.

The college undertakes continuous comprehensive evaluation process (internal evaluation) for P.G. programmes scheduled by autonomous section of the colleges Whereas at U G level the college organizes quarterly and half yearly examinations at its own level and university conducts annual examination. Unit test and comprehensive tests, quiz are conducted by the concerned teachers also at U G level

Research, Innovations and Extension

The institution has a well defined policy for promotion of research and is displayed on the institutional website. The college has mandatorily provisioned in its syllabi under Choice Based Credit. The college has a centralized research committee comprising of all PG heads and presided by the principal of the college. This committee takes responsibility of making policies regarding research and monitors the ongoing research work, provides the valuable suggestion and encouragement to the newly recruited faculty members regarding preparation of minor research projects and the state and national funding agencies. The department organizes pre-submission presentation and viva - voce for the Semester 4 students pursuing dissertation and Research scholars pursuing Ph.D degree. The college has twelve research centers recognized by the parent University where the process of admission in under process. More than 20 % teachers of the college are recognized guides. RGGPG College being a govt. institution does not have any fund to mobilize and sanction financial aid to pursue the project work or related activity. Therefore we have to depend on govt. agencies like UGC, ICSR, CGCOST for such activities. The college is situated in a remote tribal area with no corporate sector. The college has received very nominal financial assistance from banks to organize seminar/workshops.

Infrastructure and Learning Resources

The institution has 28 spacious, well cross ventilated class rooms equipped with green boards, blackboards. podiums and adequate seating facilities for learners. The College has 05 classrooms with LCD projectors for IT enabled teaching and learning. Besides, the IT facilities available in the departments, the college has set up two centralized with 50 computers having internal connectivity and UPS online services, which serves for the needs in practical of BCA, DCA, PGDCA. The college has a semi- automated centralized library with 98000 books with different category like reference books, text books, titles and various subjects among which the PG level books, journals have been transferred to the P.G departmental libraries. The college also subscribes INFLIBNET N-list, having E-learning resources, E-journals, E- pathshaala, E- shodhgranth etc. The college has a large and spacious campus serves the purpose of adequate facilities for sports, indoor and outdoor games, gymnasium etc. Among them, the hand ball ground, basketball ground, hockey stadium, football and cricket ground, volleyball court, twiquando stadium, a pewar block filled track around the playground with plantation which is utilizes for morning and evening walk by the people in the locality. The college has a helipad and a large stage where diginatories like CM. ministers and higher officials land the helicopter and the ground is utilized for public meetings and functions.

The college has two auditoriums old and new. New auditorium is 650 seater, well equipped which is utilized for cultural activities, functions of district administration. Physcal, academic, support facilities – laboratories,

library, computers and classrooms etc are maintained by janbhagidari funds and PD funds, whereas the sports facilities are maintained by amalgamated funds of college, in case if necessary janbhagidari funds maybe utilized for the purpose. The college has 50 seater E-seminar hall and a separate exam control hall. The college also has a 100 seater boys hostel and 50 seater under construction womens hostel. The college also provides purified drinking water to the students and staff through water coolers available for the same. Power supplied is backed up with the help of a grand generator and solar power plant of 10 KW capacity.

Student Support and Progression

The college has evolved the mechanism to provide the assistance to new comer students seeking admission or to come for any other work. All the information regarding admission procedure, available seats, and admission committee assigned to look after admission, fee counters and fees is mentioned in the college prospectus. Besides, all the information process and other information are uploaded on the college website.

In the beginning of the session the college organizes induction programme, in which the students are made to get acquaint with all the functionaries of the college, amenities available here, and the process to avail those facilities, enable them to acquire meaningful experiences for learning at the campus and facilitate their holistic development and progression. The college career guidance/ counseling cell organizes a workshop every year to help the students to know about the job opportunities, where to get the information, how to prepare for , when will the wants be published and to apply, what are the syllabus , how to prepare and where the material are available. The needy students with learning difficulties may directly consult the concerned department of the college with their queries or problems where they are sort out by concerned head of department and the concerned subject teachers who properly redress their grievances and provide effective remedies. The college has about more than 60% students belonging to ST category and ST/SC/OBC (non creamy layer) minorities and single girl child are benefitted with the state/ central government scholarship policy. The needy students who do not get any scholarship can apply for fee concession which is sanctioned funds from poor boys fund of the college.

In the beginning of the session slow learners are located; they are given extra care and remedial classes so that they may come in the main stream and compete with the fast learners. They are guided and encouraged to prepare for UPSC and state PSC exams, NET/ SET, so they can prepare accordingly to achieve optimal progression. Students enrolled in NSS, NCC, YRC and I semester students are compulsorily engaged in the activities to sensitize to their responsibilities.

Governance, Leadership and Management

The internal quality assurance cell of the college magaes and monitors almost all the functions regarding academic and infrastructural quality of the institution with utmost sinceriority and accountabilitry.

The College has decentralized its governance system for the assurance of the quality of educational provisions in the College. Committees consisting of teachers from different departments co-ordinate and conduct various activities and events i.e. Admission Committees admits students for various programmes, Disciplinary Committee ensures discipline, Purchase Committee supervises the purchase procedures, Anti- ragging Committee ensures un functional of ragging. Grievances Redressal Cell works for the redressal of the grievances of the students. Advisory Committee works for the redressal of grievances of staff and faculty members. Apart from this, every member of Administrative Staff is given charge of specific section. The

registrar of the College along with the Head Clerk supervises functioning of Accounts, Establishment, Purchases, Examinations and Students Affaires is accountable to the Principal.

The Principal of the College through his effective leadership ensures the optimum utilization of the inner strength of the College for the institutional developments. He makes time bound future programmes and executes accordingly. The Heads of all Departments co-ordinate the activities in their departments. Further the individual faculty members share their responsibilities in organising the activities of the students i.e. NCC, NSS, Students Union and Sports. However, the Professor incharge of these organizations, monitor the activities. Many departments of the College have its Students Associations at PG level where the students leadership quality is developed. The heads of Departments are responsible to ensure the quality education in the institution. The culture of participative management is promoted in the College through the encouragement of the faculty members, staff and students to contribute their ideas and view points, objectives and goals of the institution. The issues pertaining to effective management of academic as well as administrative are discussed in the meetings of Heads, held on regular basics. The College has also a Janbhagidari Samiti which works for the physical as well as academic development of the College.

Institutional Values and Best Practices

- 1. This large institute is spread over 42.99 acres of land in the heart of the city, Ambikapur. The campus is significant as polythene free zone and its impact upon academic excellence is well recognized in the contemporary setup. The hazards of polythene in our country are already alarming and has retrogatively affected the human life across the nation. Taking lesson from the alarming situation of polythene hazards in the metropolis, we decided to ensure a polythene free atmosphere in accordance to the demand of healthy academic environment in our campus. We conducted motivational programs based on the adverse effects of blind use of polythene accompanied with slide slow of different metros, preferably Mumbai. It is with the collaborative efforts of municipality and helping hands of intake that we finally succeeded in ensuring plastic free campus to influence healthy physical academic atmosphere. Being a region of tribal belt, the population of Surguja suffer from illiteracy particularly in terms of health and sanitation. The following activities are being undertaken to sensitize students toward key sociol issues.

Medical awareness campaign: - The district of Surguja suffers from lack of proper medical sanitation, health facilities. The student play a key role in spreading awareness towards polio, measles, rubela, vaccination, eradication of leprosy. The wing of youthRed cross spreads awareness about blood donation.

Social upliftment:- Apart from the problem of lack of literacy various social problems which hamper the growth of the area are tackled by our students. In the surrounding eural areas people indulge in various superstitious activities. The NSS Unit of College takes it as their responsibility to arrange camps in such areas and spread awareness through short skits, dramas, group songs, human chain etc. In rescent years the camps have been arranged in Keshawpur, Ajabnagar, Sakalo and Digma where students are tackled by our students. In the surrounding rural areas people indulge in various superstition activities.

Clean city Mission:- The learning impact of Swacch bharat mission is being evident in the campus. It is ensured through "Swacch Vatararn Samiti" formed by the staff and students. A keen vigilance is kept on the surroundings with a provision of green and Blue dustbins. The concept enables students to bifurcate between dry and wet garbage and their separate disposel.

Apart from College campus the mainstream of the city are also maintained by the students to make them socially responsible. About of 5000 plants are planted by the students all around the city per year to achieve the targets of green city.

4.1 Physical Facilities

This college has adequate facilities for teaching and learning. There are 28(Twentyeight) largesized classrooms which are well furnished with decent furniture. All the classrooms are well ventilated and equipped with required teaching aids like blackboards, greenboards and white boards.

These are 05 classrooms equipped with information technology (IT) instruments for use in effective teahing and learning. There classrooms have LCD projectors and Smart interactive boards to enable the teachers and learners to get the maximum possible benefit from the IT-enabled mode of communication of teaching materials.

The College has a large computer lab with an adequate number of computers with LCD monitors. To specify the number of Pcs, our computer lab has 45 (forty five) computers. All the computers are connected with local area network (LAN) for internet connectivity. The computer lab caters to the need of the students and teachers of the courses of PGDCA and BCA who are enrolled in the College. Besides these learners, the lab facilities are available for other students also for their academic needs. This lab plays a very important role in our institutional process of teaching and learning as the availability of the large number of e-learning and research resources comes to the stakeholders in a practical form through the hard and soft facilities available in this lab.

This College has 13 (Thirteen) laboratories. All the laboratories are equipped with the necessary instruments for practical work in the respective subjects. The laboratory of the physic department has 05 (five) computers to meet the needs of the departmental teaching and learning. The chemistry department has 03 (three) computers for the academic needs of the teachers and students there Besides, each of the departmental lab has a minimum of 01 (one) computer.

In addition to the physical teaching and learning infrastructure of a satisfactory level, this College subscribes regularly to the N-LIST of the INFLIBNET. Through this we have a large number of eresources in forms of e-books and e-journals in large numbers. This corpus of the large e-resources is in addition to the large number of book titles and journals that we have in our central library. It is notable that each PGdepartment of this College has its own departmental library with adequate numbers of PG and research level books and journals.

The three tier question pattern 100 words, 250 words and 700 words question has been implemented on the recommendation of the IQAC and academic council of the College to prepare the students for competitive exams like state public service commission and other inculcate descriptive abilities of students simultaneously. The College has implemented Choice Based Credit System with semester at PG Programmes under autonomous scheme with 70 marks semester exam and 30 marks in internal exams, having tests, seminar and assignment carrying 10 marks each Students have to pass internal and semester exams separately scoring 40% marks in all. Under CBCS the programmes have been provisioned with three core credit course, one other supportive course and one optional course to be selected having choices to the students. Every course under CBCS has 6 credits for 90 days teaching and a student must earn at least 4.5 credit to appear in semester exams. The students are allowed for ATKT in semester exams, but there is no provision of ATKT in internal exam.

The College implements the state Government annual performance appraisal system for teaching and non-teaching staff. Both faculty members and non-teaching staff are regulated to fill up performance appraisal form provided to them, designed by the directorate of higher ecucation C.G. govt. on 31th March at the end of every financial year. The format prescribed to the teaching staff has been so designed that it covers all the activities taken up by the faculty member throughout the academic year i.e. teaching of students, student support, various responsibilities borne by him, involvement in research activities publishing research papers, attending seminars and workshops, paper presentation, organizing seminar/workshop in the college, guiding Ph.D. and M.Phil scholars etc, enrollment in games and sports conducted in the College, examination duties, valuation works, their involvement in curricular designing in various BoS and university Bodies. 6.4.3 Institutional strategies for mobilisation of funds and the optimal utilisation of resources

The management of the institution together with initiatives of its public participation committee has submitted proposal to the state government in this regard, intimating about the financial stringency and environmental hazards. The higher education department of the institution has given the sanction with required financial assistance.

Objectives: - The objective of green energy- clean energy has become the demand of the time in such a way that all our attention should be focused upon with great social and human responsibility in such a way as we could leave as better living condition and environment to coming generations. Ours as a developing nation has so many constraints on the path of sustainable development on the one hand, and on the other, the healthy environmental atmosphere and climate for forthcoming generations. Hence the institution non-adopted a way of energy that both sustainable growth and healthy atmosphere could be ensured with responsibility and dedication.

Context: - In the light of global environmental problem it has become necessary that all the countries of the world should voluntarily work to minimize the injurious impact of fossil energy on the one hand, and on the other, hectic nuclear and atomic explosion on the other, causing the inquri and disastrous impact on human health and environment. several countries have become conscious of measures regarding

Green energy, clean energy cane ensure lessaning of cost of what is being paid for one year on one and on the other keeping in view the deteriorating environmental conditions of our towns we finally decided to cope with the available option in firm of solar energy which would not only take care of our energy needs but also ensure the better environmental condition in surrounding areas.

It is a matter of great satisfaction that we are covered by Green energy, clean energy power system via solar energy installing its required machinery to take care of our overall needs. Now we are in a position to cover all our daily needs in this mode in a competent and successful manner, though we are still retaining our old practices at minimal level. Though our state is a zero power cut, yet it on account of social and human responsibility we have adopted available viable option so as to fulfill our valuable work in ensuring healthy and better living conditions to our future generation.

Problem: -

Ours is a large campus with 100 seater boys hostel and 50 seaters girl's hostel, professor colony, gymnasium and Taiquando court as well but available facility is confined only to our academic and administrative building only We are looking forward to cover our entire campus with green energy, clean energy but financial constraints are there, which could be redressed with assistance from the UGC and state government authorities. After being assisted with funds the sources mentioned we would look towards extending its potential up to 20 kilo watts against existing 10 kilo watts.

Note: - Green energy, clean energy is appreciable option available and we all should look towards this option. We usually feel hesitant on account of our larger areas and budget. It can be done in installment in accordance with availability of our budget, and once it is 100 talled and stals looking, it fintions with zero maintaince charges for almost ten years, hance it is projected as energy and well as movirinement friendly which is in utmost demand.

Best Practics-II

Title of the practice- Plastic free green campus.

2- Objectives of the practice – The college conducts a large number of practices in its campus on the vision, mission and objective of the college. The college also understands its responsibilities towards regional state, national and ultimately global challenges regarding global warming, plastic hazards and preservation of bio- diversity. The College strives at the promotion of green practices and therefore, plants hundreds of plants in the campus and outside the locality through its NSS, NCC, YRC, students and faculty members.

The Context: - The practice is designed and implemented to meet the challenging issue related to environmental pollution and global warming reading to the most dangerous points and therefore it has been very burning issue for the world and our earth the green planet. The global meeting has been conducted in Brazil in 2015 to limit the release of the gases creating green house effect. So to control release of gases creating green house effect and in promises of our prime-minister, the college does not only hold plantation programmes in campus but also strives at their protecation. The students and faculty also underlake the programme making the campus plastic free, weekly on every Saturday under Swachhata Abhiyan. The faculty members along with the students collect all plastic hazards and deposit them at one place and send them to the saste management centre of the local municipal corporation.

The Practice:— Making the campus green and plastic-free is very unique practice in the context of higher education in India. The College has a large spacious campus of 42.99 acres. The College in centrally and density planted trees and safeguarded on plantation area alongwith the outskirt of its ground. The college has also developed a Golden jubilee garden with plots of green grasses, beautiful show plants, flowers and hedges in the garden. Besides, the college has a separate Botanical Garden, where students of Botany plant and develop the greenery necessary for their practical point of view. The students of Botany also cultivate medicinal plants from dense forest of locality and learn their medicinal properties and are motivated to cultivate them for business purposes to cultivate medicinal plant for their use and earning. The plastic hazards are also very dangerous for the environment and for human existence. The college constantly motivates the students and staff to work toward ridding their surroundings of the hazards of plastic.

Evidence of success: - The success of the practice is clearly seen in the campus of the college. There are about 2000 trees/plants growing in the College campus and therefore sufficient greenery is available here Besides the centralized plantation area, jubilee garden, and Botanical garden, the college has a walking track surrounded by green plants, which are pleasant to the people of the local community coming for morning and evening walks. The front of the college is well decorated and maintained by the local municipal corporation. The college is having such a large public ground in the district that many public programmes and events are organized here, still the campus is free from plastic hazards and garbage. IT is the evidence of the success of the practice. Problem encountered and resources required. The college encountered the problem of resources for plantation and tree guards and maintaining the campus. The public programmes, public assembly when organized fill the campus with plastic hazards and garbage.
