Action Taken Report for Employer Feedback (Session 2019-20)

Feedback Overview: The employer feedback for the academic session 2019-20 was collected to evaluate the relevance of the curriculum, leadership development, skill inclusion, and the application of industrial knowledge. Based on the feedback, appropriate actions were proposed to improve curriculum delivery and effectiveness.

1. Relevance of Curriculum

- **Feedback:**
 - 88.5% of employers strongly agree that the curriculum is relevant to local, national, and global needs.
 - 11.5% of employers agree with the curriculum's relevance.
 - **Action Taken:**
 - The college curriculum committee will continue aligning course materials with industry standards and global trends to maintain high relevance.
 - Regular industry input will be sought to further enhance the curriculum's adaptability to changing global scenarios.

2. Fostering Leadership

- **Feedback:**
 - 57.7% of employers strongly agree that the curriculum fosters leadership and initiative.
 - 42.3% of employers agree.
 - **Action Taken:**
 - Leadership workshops and interactive sessions with industry leaders will be introduced to enhance leadership skills.
 - Practical projects and group activities will be incorporated to further encourage leadership qualities among students.

3. Applied Aspects

- **Feedback:**
 - 57.7% of employers strongly agree that the curriculum includes practical aspects like hands-on training and industrial visits.
 - 42.3% of employers agree.

- **Action Taken:**
 - More frequent industrial visits and collaborations with local industries will be arranged to increase hands-on exposure.
 - Laboratory and fieldwork activities will be enhanced to further strengthen practical learning.

4. Inclusion of Skills

- **Feedback:**
 - 50% of employers strongly agree that the curriculum effectively includes soft skills and computer literacy.
 - 50% of employers agree.
 - **Action Taken:**
 - New modules focusing on soft skills, communication, and advanced computer literacy will be introduced to bridge the gap between education and industry requirements.
 - A dedicated program for skill enhancement will be designed with regular assessments.

5. Course Content Effectiveness

- **Feedback:**
 - 73.1% of employers strongly agree that the course content helps in learning new methods and technologies.
 - 26.9% of employers agree.
 - **Action Taken:**
 - The curriculum will be updated to include the latest industry technologies and methodologies.
 - Training sessions and workshops on emerging technologies will be organized to keep both students and faculty up-to-date.
