Action Taken Report: Teacher Feedback 2021-22

1. Curriculum Revision and Relevance

- Feedback: 55.3% strongly agreed, and 44.7% agreed that the curriculum is revised and relevant based on trends and local needs.
- Action Taken: The curriculum was regularly reviewed and updated to incorporate current trends and address local community needs, ensuring its continued relevance.

2. Autonomy in Curriculum Designing

- Feedback: 50% agreed, and 47.4% strongly agreed that sufficient time and autonomy
- were available for curriculum designing.
- Action Taken: Continued support for faculty autonomy in syllabus framing, with time allocated for revision as per evolving educational needs.

3. Clarity of Course Objectives and Outcomes

- Feedback: 57.9% strongly agreed, and 42.1% agreed that course objectives and outcomes are clear and well-aligned with program goals.
- Action Taken: Ongoing efforts were made to maintain clear alignment between course units and learning outcomes, ensuring transparency and focus in educational delivery.

4. Employability and Entrepreneurship Skill Development

- Feedback: 63.2% agreed, and 34.2% strongly agreed that the curriculum incorporates employability and entrepreneurship skills.
- Action Taken: Strengthened modules focusing on entrepreneurship and employability through internships, industry collaborations, and skill-based workshops to prepare students for real-world challenges.

5. Inclusion of Bloom's Taxonomy

- Feedback: 63.2% agreed, and 31.6% strongly agreed that the syllabus effectively integrates different learning levels based on Bloom's Taxonomy.
- Action Taken: Teacher training was enhanced to better implement Bloom's Taxonomy in curriculum design, ensuring cognitive skill development across varying levels of complexity.

6. Integration of Values and Life Skills

- **Feedback:** 52.6% agreed, and 44.7% strongly agreed that the curriculum incorporates social, moral, and ethical values along with life skills.
- Action Taken: Broadened the scope of life skills and values education by introducing more discussions and activities focused on ethical, environmental, and gender-related issues.

7. Academic Flexibility

- Feedback: 57.9% agreed, and 39.5% strongly agreed that there is sufficient academic flexibility through elective courses.
- Action Taken: New elective and interdisciplinary courses were introduced, offering students increased flexibility and the ability to explore diverse academic interests.

8. Availability of Teaching Resources

- Feedback: 55.3% agreed, and 42.1% strongly agreed that the necessary teaching resources, including reference books, are available.
- Action Taken: Teaching resources were expanded through digital access and updated reference materials, ensuring that students and faculty had the tools needed for enhanced learning.

9. Co-Curricular and Extra-Curricular Activities

- Feedback: 57.9% agreed, and 39.5% strongly agreed that co-curricular and extracurricular activities effectively contribute to personality development.
- Action Taken: Co-curricular and extra-curricular programs were further enriched with activities focusing on personal development, leadership, and creativity.

10. Inclusion of Stakeholders' Suggestions

- Feedback: 55.3% strongly agreed, and 44.7% agreed that stakeholders' suggestions were effectively included in curriculum decisions.
- Action Taken: Regular consultations with subject experts, alumni, and industry representatives were conducted to incorporate valuable insights into curriculum revisions.
