The Minutes of the Meeting

The following resolution were passed unanimously-

1. Approved LL.B Choice Board Credit System Syllabus (CBCS). The Vth Paper of all Semesters will be elective in the following manner-
 - a) In LL.B First Semester, Legal Language, Legal and Constitutional History of India, Media Law will be added as Elective Paper V-A, V-B & V-C respectively.
 - b) In LL.B Second Semester, Criminology & Penology, Comparative Constitution, Competition Law will be added as Elective Paper V-A, V-B & V-C respectively.
 - c) In LL.B Third Semester, Law of Equity & Indian Trust Act 1882, Election Law, Banking Law will be added as Elective Paper V-A, V-B & V-C respectively.
 - d) In LL.B Fourth Semester, CG Land Revenue Code & Rent Control Act, 2011, Animal Protection Law, Local Self Government including Panchayat Administration will be added as Elective Paper V-A, V-B & V-C respectively.
 - e) In LL.B Fifth Semester, Interpretation of Statues, Insurance Law, Women and Children Law will be added as Elective Paper V-A, V-B & V-C respectively.

f) In LL.B Sixth Semester, Human Rights Law, Cyber Law & IT Act 2000, Right to Information Act, 2005 will be added as Elective Paper V-A, V-B & V-C respectively.

2. Approved 'Understanding India' as the course of Undergraduate Semester-II.

3. In LL.M-

a) Semester III Paper IV (All Groups), "Intellectual Property Rights, Human Rights and Environment: Basics" which was irrational, has been renamed as 'Intellectual Property Rights'.

b) In Unit I, "Law of Patents" has been substituted by 'Introduction, Nature, Basic concepts & International conventions'.

c) In Unit III, "Human Rights" has been substituted to "Law of Patents- Meaning, criteria for obtaining patents, Non-Patentable inventions, procedure for registration, Term of Patent, Compulsory license, Infringement of Patent and Remedies.

d) In Unit IV, "National Human Rights Commission, State Human Rights Commission" has been substituted by Law of Trademarks: Meaning, categories of Trademark, concept of distinctiveness, doctrine of honest and concurrent use, procedure of registration, Assignment and Licensing, Infringement and Passing off.


e) In Unit V, "Design and other forms of Geographical Indications (G.I), Design: Meaning of Design protection , concept of original design, Term , Geographical Indication: Meaning of G.I, Difference between G.I & Trademark, concept of authorized user, has been added.

4. The proposed Syllabus will be enforced from the current session 2022-2023.


5. The rest of the Syllabus will be adopted as it was during the previous Session.
